CNDC (Melinda Higgs, CNDC President & CEO)

- Presentation about the relationship between Colorado Nonprofit Development Center (CNDC) and the GTCD
 - Fiscal sponsorship organization, partner for 501(c)(3)
 - Provides back-office support, compliance, HR services, accounting, legal, etc., so projects can focus on community work

- Projects benefit quality of life for Colorado
- o CNDC serves as our accountant, bank, HR, insurance agent, etc.
- Project (GTCD) pays overhead cost 10% of non-government income, 14% of government income, with some exceptions

- Q: When are the next available CNDC orientation classes offered? Need help understanding the finances piece. (A. Harris)
- o A: Melinda will send information
- Q: Applying for some grants have been a problem for us since we're not our own 501(c)(3). Rules regarding grants? Is there a process for projects to become their own 501(c)(3)? (J. Mosley)
- A: Arts part of the nonprofit sector is non-friendly to business institutions. We think some funders are misinterpreting statues and we continue to work on this. We will assist any group with the process to become own 501(c)(3). Help look at cost/benefits.
 Depends on your goal. Application is easy, more difficult part is replacing the backoffice. We have other models of support.

- Neighborhood Improvements Committee A. Perkins/P. Dikeou
 - Big focus working on community murals and pollinator garden. Thanks to all who helped to paint, had over 50 volunteers. Pollinator garden coming soon. Compost project will not be happening – SCRAPS won't be doing this anymore because most buildings will be required to compost.
 - Continuing to move forward on special district conservations
- Urban Design Committee A. Iltis
 - April 6 meeting discussed Cherokee Row project, second meeting. Massing approved. A lot of conversation about parking and dogs. Comments about façade and ADA access.
 - 5280 Trail on Acoma City engaged in program DDP helped facilitate in Indianapolis (Cultural Trail) in April. Got project team excited about Acoma. Questions about neighborhood vision came up, and how to bring the vision forward. Contractor procurement by July, then begin design process. Reminded team that GTCD and community wants to help support.
 - UD Committee meets second Thursday of month at 8 am, when presentation time is requested by developers. Developers required to present twice to committee.

 - Next meeting Friday, May 12 at 7:30 am at Colleen Fanning Art Advisory
- Events Committee A. Chase
 - o GTCD Events Committee
 - Spring Fling was a success. Raised money, hosted approximately 100 guests.
 - Best year we raised \$30K, prior to the pandemic; revenue not as good since pandemic.
 - Earned \$24K, expenses low, around \$5K because so much was given in kind
 - Catering was outstanding and all provided for free. Catering value \$20-25K.
 Highly recommend Dark Steele Gastro Arts.
 - \$14,500 in sponsorship and in-kind donations
 - Overall revenue \$3,600 auction, tickets \$5K. Consider, do we need to increase attendance for future events, increase ticket prices, increase price for drawings, have more silent auction items?
 - MaxGiving platform worked great for our purposes. Recommend for future events (\$500), have access for 1 year.
 - Everyone who donated will get a tax receipt, generated by CNDC.

- I sent an email to the Board mid-April regarding the GTCD Litter League group. Pablo responded and said he would be willing to help. Does anyone have thoughts they would like to share about moving forward with our Litter League program or have suggestions about a different approach? - Khiember Wiskamp (and Morgan Hayes) Just purchased building at 1024 Cherokee St. for a clothing retail and manufacturing business, Clotheory. We are excited to be a part of the Golden Triangle community and seeing what we can offer to the community in fashion.
- Kathleen Perniciaro, speaking as parent of a student at The Wonder Academy. See Addendum.
- Julie Giehl, speaking as parent of a student at The Wonder Academy. I have similar comments.
 We chose The Wonder Academy for good reason commitment to higher pay for teachers and
 focus on childen as important members of the community. Devastated that The Wonder
 Academy will be torn down to build more apartments. There are no plans for early childhood
 education in the 2014 Golden Triangle Neighborhood Plan. Children are stakeholders in
 community. Asking you to advocate for services and schools for children under the age of 6.
- I encourage you to attend Urban Design Committee meetings to voice your concerns to developers and attend Denver City Council meetings and share comments during public comments period. (L. Beauchamp)
- Shannon Hoffman Will this project be discussed again at an Urban Design Committee meeting? Can the group be directly connected to developer?
- Developer information is public record. (L. Beauchamp)
- We want to keep kids in the neighborhood. Thank you fo coming to raise your concerns. We're happy to be here to provide a platform we hope we can help advocate for your needs.
 (J. Mosley)
- Thank you for highlighting this important issue. It's the biggest threat to our city center neighborhoods – hard to find quality schools and good day care. My understanding is that developers have not closed on the property. When did The Wonder Academy announce they are closing and are they looking for other sites? (A. Perkins)
- Julie Giehl Sale closes at end of July, parents notified 3 weeks ago. Building for infants through 2 ½ years has more strict licensing requirements. Build out, timing, physical needs for child care challenging.
- We have focused on residents in our conversations. Need to consider people in the neighborhood who receive services on a daily basis as well. (A. Iltis)
- Need to look at creating incentives for developers to provide early childhood education. As a neighborhood organization we can begin advocating for these needs in the neighborhood. (A. Perkins)
- I'm willing to have a conversation with the City Librarian to see how we can help advocate for these needs. (R. Fewell)
